ELECTRONIC INVOICING

In Panama

In December 2016, the Panama government launched the Panama Electronic Invoice System (SFEP) in order to implement electronic invoicing throughout the country.

The pilot plan for the implementation of the electronic invoice began in September 2018, establishing the technical characteristics and the names of the companies authorized to issue invoices electronically. The plan is designed to ensure that all businesses are using electronic invoicing by January 1, 2023. This will help to streamline businesses' invoicing processes and improve efficiency.

As a result of the publication of Executive Decree N°25 on June 27, 2022, new entities are now required to implement the Panama Electronic Invoicing System (SFEP).

ELECTRONIC INVOICE SYSTEM

SFEP

It is important for taxpayers to ensure that they are contracting with an Authorized Certification Provider (PAC) in order to be able to electronically bill and exchange electronic documents. The PAC must validate the invoices before they are sent to the DGI for control.

EDICOM has been accredited by the General Revenue Directorate of the Republic of Panama (DGI) as a Qualified Authorized Provider (PAC) of Electronic Invoicing in Panama. This accreditation was granted by means of Resolution No. 201-7569 of November 14, 2022.

CHARACTERISTICS OF THE ELECTRONIC INVOICE

FORMAT

The XML electronic format will be used in accordance with the Technical Data Sheet established by the DGI.

TAX CONTROL

Each invoice must be uniquely identified by the Unique Electronic Invoice Code (CUFE).

STORAGE

Both issued and received electronic invoices must be stored for 5 years, until the statute of limitations for ITBMS or VAT taxes expires.

DIGITAL SIGNATURE

The legal validity of the invoices will be guaranteed by the electronic signature of the issuer, ensuring the authenticity and non-repudiation of the invoices.

REQUIREMENTS TO BE AN ELECTRONIC INVOICE ISSUER

1. To have received the Exception for the use of Fiscal Equipment from the DGI.
2. To be registered in the Electronic Invoice System of Panama.
3. Have a Qualified Authorization Provider (PAC) that provides the Authorization of Use of electronic documents and through which to issue and receive electronic invoices according to the specifications established in the Technical File.
4. To have a qualified certificate issued by a certification provider accredited by the National Directorate of Electronic Signature of the Public Registry of Panama, to electronically sign electronic documents.

How it works

EDICOM prepares a single data interface to integrate your management system into the EDICOM Platform.

The Platform establishes connections with the ERP to integrate the client's data file, transforming it to the electronic invoicing standard required by each public administration

A check is then made of the data for each structured format together with semantic and syntactic validations to verify that the electronic document does not contain any errors.

The legal compliance module integrates the technical and legal specifications of each electronic invoice model for the countries in which your company operates. In addition, it implements any digital signature systems, electronic time stamps or tax control processes stipulated by current legislation.

The invoices generated are automatically sent to the recipients through the EDICOMNet communications module, previously verifying communications with public authorities or their business partners.

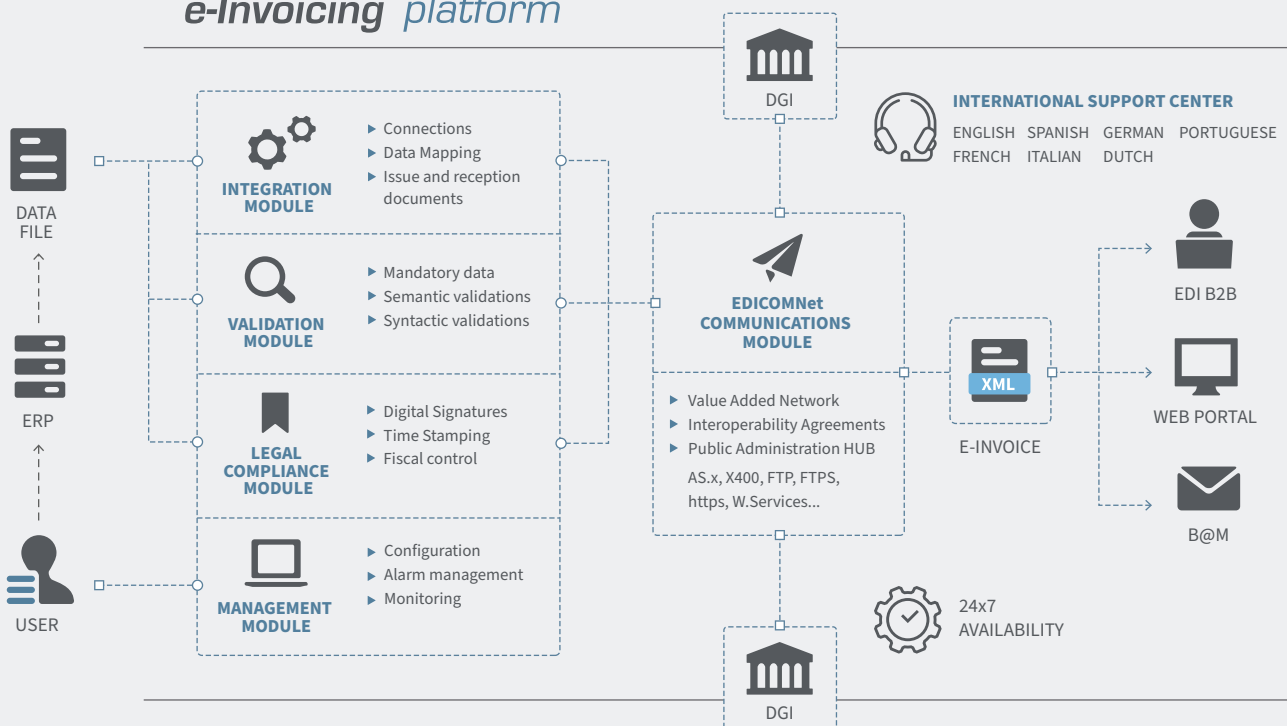
