How it works

The EDICOM platform sets up an environment for **each invoice-issuing country** subscribing to its tax authority.

EDICOM works along with you to prepare a unique data interface to **integrate your management systems with the EDICOM platform**. This way, every time a user in your organization issues a bill in your in-house management system, the interface comes into play to automate issuing of the e-Invoices.

The EDICOM platform **recognizes the invoice issuing country**, redirecting it to the environment configured for processing according to each country's specifications.

The EDICOM platform transforms the data from the ERP into the **e-document schema required in each country** (XML, EDIFACT, X12, and others).

EDICOM **automates signature of the invoices**, as well as communications with the tax authorities when online tax returns or the application of particular validations are required.

The invoice created is stored in EDICOMLta (Long-term Storage Service), which **ensures legal safekeeping of all the documents stored throughout their term**, in accordance with the technical specifications of the different international standards, or the local legislation of each issuing framework, where indicated.

The duly **validated document is forwarded to the recipient through EDICOMNet**, the EDICOM multiprotocol private network.



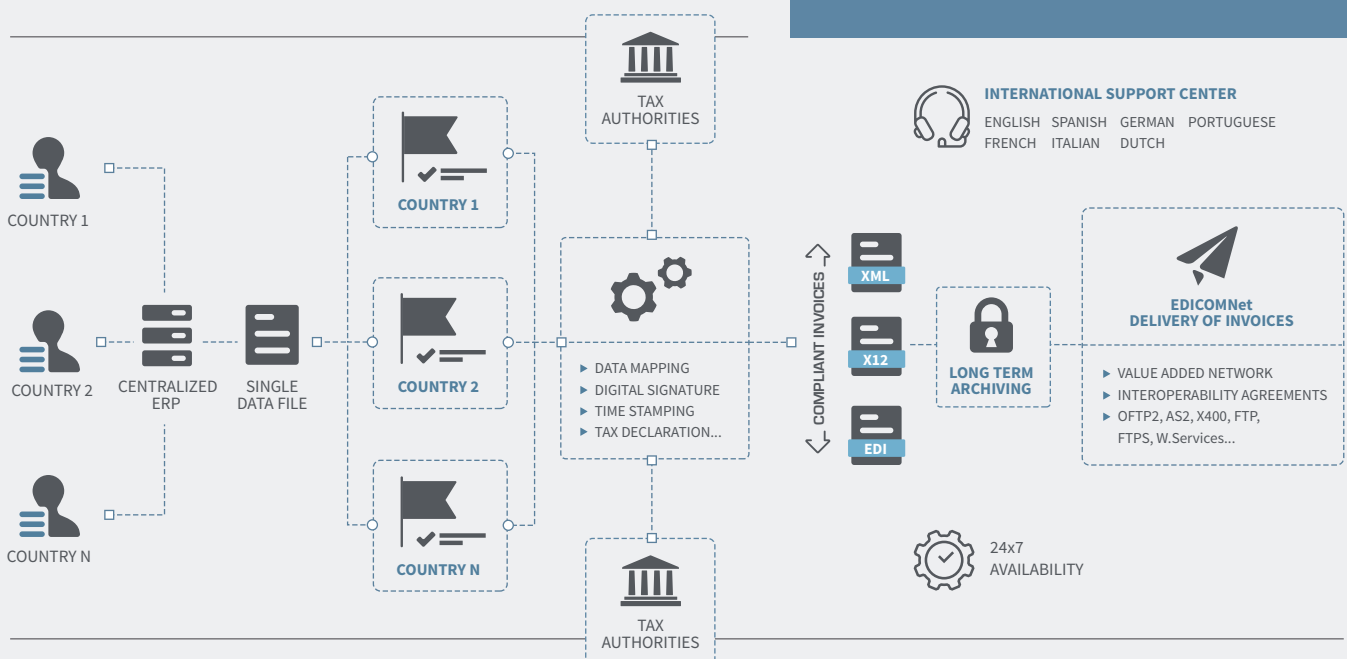
