You won't have to install or maintain your own OFTP server, facilitating the simple, straightforward exchange of all electronic transactions and CAD/CAM/CAE engineering files via the protocol most commonly used in the sector.

A team of specialized consultants and support managers are tasked with the production launch and monitoring of all the integrations required to consolidate or synchronize your internal applications.



How it works

- EDICOM works with you on preparing the **integration files** for each document to integrate in your management system with the EDICOM platform.
- The platform establishes the ERP connections to integrate the data file agreed on with the customer, **transforming it into the standard required** in each case (EDIFACT, X12, XML, VDA, ODETTE, CAD/CAM/CAE files, proprietary formats...).
- Data is then checked for each structured format and **semantic and syntactic validations** are run to ensure that the e-document is error-free.
- The EDICOM platform integrates the technical and legal specifications of each e-invoice or e-VAT model in the countries where your company operates. It also implements the **digital signature and e-time stamp systems and tax control processes** determined by the laws in force.
- The generated documents are automatically sent to the **recipient via the agreed-on communications protocol**, having previously identified the EDI communications with your automotive sector partners or public administrations and tax authorities.


